office of the district attorney; and

WHEREAS, in light of the foregoing, the Court having considered the petition, amicus brief, and responses and being sufficiently advised, Chief Justice Judith K. Nakamura, Justice Barbara J. Vigil, and Justice Michael E. Vigil concurring;

NOW, THEREFORE, IT IS ORDERED that the petition is GRANTED and a writ of mandamus shall issue directing the Secretary of State not to implement Chapter 212, Subsection 103(B)(17) of New Mexico Laws of 2019;

IT IS FURTHER ORDERED that the writ of mandamus shall direct the Secretary of State to include the office of the district attorney on the 2020 general election proclamation and the 2020 primary and general election ballots;

IT IS FURTHER ORDERED that the oral argument set for this matter on Friday, September 13, 2019, is VACATED; and

IT IS FURTHER ORDERED that an opinion explaining the decision of the Court shall issue at a later date.
